Proceedings No. RVG 10136/2026

By Order No. 152/2026 dated 30 July 2026, the Delegated Judge, **Dr Alessandra Mirabelli**, has ordered as follows:

IT IS HEREBY ORDERED

that the hearing pursuant to **Article 19 (co. 3) of the Italian Code of Business Crisis and Insolvency (CCII)** be scheduled for:

- **Company:** TECNOAL S.R.L.

- **Appointed Expert:** Attorney Elena Ceserani
Certified Email (PEC): elenaceserani@ordineavvocatibopec.it;
- **Creditors;**

Hearing date: 16 September 2026 at 11:30 a.m.

The Court further orders that the applicant company shall, **no later than 14 August 2026**, serve the petition and this Order upon:

- the appointed Expert;
- creditors (other than employees) holding claims, whether due or not yet due, exceeding **EUR 5,000**, and, in any event, creditors who have commenced judicial or out-of-court debt recovery actions, as identified in the list to be supplemented within seven days, by certified electronic mail (PEC) to the address appearing in the Companies Register or the INI-PEC register or, where unavailable, by ordinary e-mail to an address whose ownership has been verified or is capable of verification.

As regards all other creditors, publication of this extract in the Italian Companies Register, together with publication of the same extract in both **Italian and English** on the applicant company's website within the prescribed time limit, shall be deemed sufficient.

The Court further:

- **Invites** the applicant and the Expert to file a general notice containing the information referred to above;
- **Grants** creditors and any other interested parties until **14 September 2026** to enter an appearance in the proceedings. Alternatively, parties wishing only to attend the hearing remotely shall submit the above-mentioned documentation to the Expert by **14 September 2026**;
- **Invites** the Expert to file, by **8 September 2026**, a concise report on the activities carried out and those intended to be carried out in facilitating negotiations between the entrepreneur, the creditors and any other interested parties, on the existence of concrete prospects for business recovery, on the outcome of the practical viability test to be performed by the entrepreneur with the Expert's assistance, and expressing the Expert's opinion as to whether the requested protective measures are appropriate to ensure the successful conduct of the negotiations;

- **Invites** the Expert to file all documentation received from creditors by **12:00 noon on 15 September 2026**;
- **Orders** the applicant company to file electronically, at least eight days before the hearing:
 - the list of persons upon whom service has been effected together with their respective PEC or verifiable ordinary e-mail addresses;
 - evidence of service (including the duplicate *.eml* files of the PEC acceptance and delivery receipts);
 - proof that, within twenty days of notification of this Order, the request for publication in the Companies Register of the general docket number of these proceedings pursuant to Article 19(1) CCI has been filed;
- **Appoints Dr Luca Magi** as the Court's technical assistant. He shall have access to the case file and all relevant documentation, may obtain information from the applicant company, its advisers, the Expert, the creditors and any other parties involved (including, by way of example, the lessee), and shall file a report by **14 September 2026** addressing the matters indicated in the grounds of the Order, including confirmation of the completeness and regularity of the notifications and publications ordered above, and shall attend the hearing.
